The Notice for Inviting Tenders was on single stage two envelope basis floated for the "SUPPLY & INSTALLATION OF 100 KVA DIESEL GENERATOR SET FOR HOSTELS AT NEW CAMPUS" in the leading National Dailies ie The Dawn, The Jang & The Kawish on 07-10-2021 and also the Bidding Documents were uploaded on SPPRA PPMS website and PUMHSW website.

A meeting for opening of the technical proposals for subject work was held in the office of Project Director Engineering Wing on 02-11-2021 at 02:30 pm. The following members of Tender Opening & Evaluation Committee were present.

The Project Director (PUMHSW) briefed the Committee members that the sealed Tenders were invited from the contractors as per SPP Rules 2010 (Ammended-2013) for the said work vide NIT No. PUMHSW/P.D/2021/6188, which appeared in leading national dailies ie The Dawn, The Jang & The Kawish Dated 30-09-2021 and SPPRA PPMS Website & PUMHSW Website. He further briefed that purchasing date started from 07-10-2021 to 23-10-2021, submission date was on 26-10-2021 upto 10:00 am, whereas Opening date of

the tender was same day ie 26-10-2021 @ 10:30 am. Due to amendment in bidding documents as per SPPRA Rules the dates were extended for one week ie purchasing date upto 30-10-2021 and submission date was 02-11-2021 at 02:00 pm, whereas opening date of only Technical Proposals was same day at 02:30 pm. The Project Director (PUMHSW) further briefed that only (05) companies purchased the bidding documents detailed below;

1. M/s Usman Engineering Works.
2. M/s Jaffer Bros. (Pvt) Ltd.
3. M/s Umer Brothers.
4. M/s S.M Jaffer & Co.,
5. M/s S.S Marketing & Advertising (Pvt) Ltd.

Following contractor companies participated in the opening of technical proposals;

1. M/s Usman Engineering Works
2. M/s Umer Brothers
3. M/s S.S Marketing & Advertising (Pvt) Ltd

It is pertinent to mention here that one of the bidders namely M/s Jaffer Brothers (Pvt) Ltd had sent the bidding documents (Technical & Financial Proposals) through courier on wrong address ie to the Vice Chancellor which were opened erroneously by the staff of Vice Chancellor, whereas the Bidding Documents were to be sent on the address of Project Director Office as mentioned in the NIT. However, the Tender Opening & Evaluation Committee rejected the bid.


The technical proposals of all the three (03) bidders were evaluated and two companies qualified except M/s S.S Marketing & Advertising (Pvt) Ltd. The date of opening of Financial Proposals was scheduled on 10-11-2021 at 02:00 PM. Then all the qualified bidders were invited on 10-11-2021 at 02:00 pm in the office of Project Director Engineering Wing, so that financial proposals can be opened in their presence under Rule-41 of SPP Rules 2010 (Amended-2013). Following Contractors took part in the bidding process;

1. M/s Usman Engineering Works.
2. M/s Umer Brothers.

The Committee started proceedings of opening of tender in front of aforementioned bidders and read aloud the names of each bidder one by one by opening their respective bids and bid amount. Details are given as under;

The bids were checked arithmetically and their C.D amount were also checked @ 5% of corrected bid amount as detailed below;

The rates of 1st lowest bidder have been analyzed and the Committee is of the opinion that the same are reasonable, workable within SPPRA Rules and commensurate with present market trend, so it recommends that the work, **"SUPPLY & INSTALLATION OF 100 KVA DIESEL GENERATOR SET FOR HOSTELS AT NEW CAMPUS"** may be awarded to 1st lowest bidder ie M/s Usman Engineering Works, Hyderabad at total tendered cost of **Rs. 22,997,500/=**.
