He further briefed that purchasing date started from 18-12-2020 to 04-01-2021, submission date was on 07-01-2021 upto 12:00 noon, whereas Opening date of the tender was 07-01-2021 @ 01:00 pm. The Project Director (PUMHSW) further briefed that only (07) companies purchased the bidding documents detailed below;

Five (05) bidders submitted the bids in time. Then all the contractors were called in Conference Hall of Vice Chancellor's Secretariat, so that bidding documents can be opened in their presence under Rule-41 of SPP Rules 2010 (Amended-2013). Following Contractors took part in the bidding process;
