The Project Director (PUMHSW) briefed the Committee members that the sealed Item rate Tenders were invited from the contractors as per SPP Rules 2010 (Ammended-2013) for the said work vide NIT No. PUMHSW/P.D/2020/5750, which appeared in leading national dailies ie The Dawn, The Jang & The Kawish and SPPRA PPMS Website & PUMHSW Website on 19-11-2020. He further briefed that purchasing date started from 20-11-2020 to 08-12-2020, submission date was on 10-12-2020 upto 11:30 am, whereas Opening date of the tender was 10-12-2020 @ 12:00 noon. The Project Director (PUMHSW) further briefed that only (06) companies purchased the bidding documents detailed below;

2. M/s Sindh Construction Company, Nawabshah
3. M/s Saleem Engineering Construction Company, Naushahroferoz
4. M/s ABM Enterprises, Nawabshah
5. M/s Royal Business & Company, Nawabshah
6. M/s M. Jamil Furniture Mart, Nawabshah.

Three (03) bidders submitted the bids in time. Then all the contractors were called in Conference Hall of Vice Chancellor's Secretariat, so that bidding documents can be opened in their presence under Rule-41 of SPP Rules 2010 (Amended-2013). Following Contractors took part in the bidding process;


1. M/s Royal Business & Company, Nawabshah

The Committee started proceedings of opening of tender in front of aforementioned bidders and read aloud the names of each bidder one by one by opening their respective technical & financial bids and bid amount. In the same sitting firstly the technical bids were opened & evaluated. All the three submitted bids were found qualified, then the financial bids were opened and the details are given as under;


The bids were checked mathematically and their C.D amount were also checked @ 4% of corrected bid amount as detailed below;




