- (i) The bidder should submit two separate sealed envelopes. One envelope should contain the Technical Proposal and the other envelope should contain the Financial Proposal. Both envelopes should be clearly marked “Technical Proposal” and “Financial Proposal along with pay order of 5%”.
- (ii) The place of Issuance, Submission and Inquiries will be the Purchase Officer, PUMHS (0244-366210). The place of opening will be Lecture Hall at Peoples University of Medical & Health Sciences, Nawabshah, SBA and Sindh.

After the evaluation & approval of the technical proposals by the technical committee on the basis of the documents drawings, feature of the Printing Materials / samples of described items in the catalogue, the PUMHSW shall at a time within the bid validity of minimum of 90 days publicly, open the financial proposals of the technically accepted bids only, on the date and time communicated later by this university to the technically approved bidders. The financial proposals of bids found technically nonacceptable shall be returned without opening Financial Proposals to the respective bidders.
7. The Central Purchase Committee may cancel / delete any item as per SPPRA Rules. Tender who do not fulfill the terms and conditions will not be entertained. The procuring agency may reject all or any bid subject to the relevant provisions of SPPRA Rules
8. In case the tender is not opened on the scheduled date due to unscheduled holiday then the same shall be submitted & opened on next working day, the other terms and conditions of the tender shall however remain unchanged.
