The Committee was apprised that the Notice Inviting Tender as captioned above was hoisted on the website of PUMHWS and SPPRA only. The technical bids were opened in the presence of the Central Purchase Committee and the representatives of firm on November 11, 2021 at 02:00 PM. The total **One** bid was sold and **One** bidder submitted the bid through Single Stage-Two Envelope, i.e. M/s Ali Hasnain Printing Process.


In this regard, it was briefed to the Committee that technical bid will be evaluated with reference to pre-defined criteria mentioned in the bid document i.e. Mandatory Documents Required and Evaluation Criteria. The Committee is empowered to accept or to reject any proposal, which fails to fulfill the specified requirements. The Committee assessed the technical bid and rated as per Evaluation Criteria. The main points of committee findings are narrated below:




With respect to Bidding Document, the bidder has to furnish mandatory documents as mentioned in Document Check List. The Committee found that M/s Ali Hasnain has submitted all necessary documents and quoted specification and printing sample paper were as per requirement mentioned in bid document thus recommended as Responsive. The marks were also given to the bidder as per parameters mentioned in the Evaluation Criteria.


Given the aforementioned comments, the Mandatory Document Checklist and the Bidder's Evaluation Report are enclosed at Annexure-A and B respectively. The Committee has found following bidder as Responsive i.e. **M/s Ali Hasnain Printing Press**. Therefore, the Committee recommended to open the financial bid of Technically Responsive Bidder.


