




Proceedings: The meeting commenced with the recitation of Quraan by the Chairman, Prof. Dr. Muhammad Saleh Khaskheli [Registrar].


Opening Remarks: The Deputy Director Purchase apprised the Committee that the technical proposals were opened on the scheduled date i.e. June 3, 2024; the five bids were received as mentioned in the attendance sheet. As per minutes of technical opening meeting, the technical evaluation meeting was scheduled on June 8, 2024.


1. **Technical Bid Opening:** With reference to the meeting agenda, the committee was briefed that bids will be evaluated as per pre-defined criteria given in bid document i.e. Firstly-Evaluation of Mandatory required documents (**Annexure-A**); Secondly, bidder's qualification report (**Annexure-B**) and thirdly item's qualification report as per required specification (**Annexure-C**). Brief details are narrated as under:
 - a. The committee assessed the technical proposals of all bidders and found that all bidders have submitted required documents except Ms/ MH Kalyar Enterprises, as mentioned in Mandatory Required Documents **Annexure-A**. Thus, the committee unanimously disqualify the technical proposal of Ms/ MH Kalyar Enterprises.
 - b. The committee rated bidders as per criteria and attached documents, as mentioned in **Annexure-B**.
 - c. The committee verified that the quoted items are as per required specification, as mentioned in **Annexure-C**.
2. **Decision:** The Committee recommended to open the financial bids of technically qualified or responsive bidders and to return the sealed financial proposals of disqualified bidders.
3. **Next Meeting:** The date and time for the next meeting will be June 12, 2024.


