



MEMORANDUM OF AGREEMENT BETWEEN PEOPLES UNIVERSITY OF MEDICAL & HEALTH SCIENCES FOR WOMEN SHAHEED BENAZIRABAD AND YOGYAKARTA STATE UNIVERSITY, INDONESIA

IN THE FIELD OF HUMAN RESOURCE AND RESEARCH DEVELOPMENT

This Memorandum of Agreement (MoA) is made and executed as addendum of Memorandum of Understanding (MoU), between Peoples University of Medical & Health Sciences for Women (PUMHSW) Shaheed Benazirabad (SBA), Pakistan through its Vice Chancellor/nominee (herein after called Party-I) and Yogyakarta State University (YSU), Indonesia, through its Vice-Rector/nominee (herein after called Party-II).

WHEREAS, both the parties are desiring to work in collaboration with each other for the benefits of their students and faculty, with the prime objective of promoting education and research in fields of mutual interest.

BOTH THE PARTIES ARE AGREED UPON THE FOLLOWING TERMS AND CONDITIONS

ARTICLE 1 HUMAN RESOURCE DEVELOPMENT

- 1.1 Party II will give the internships to the fresh degree holders from the Party-I. The number of internees from both the parties will be determined with the mutual consent of both parties depending on the modules, durations and level of internees. Party-I will consider the requirements of the party-II in recommending these trainees.
- 1.2 Different seminars and workshops will be arranged time to time either in the Party-I and Party-II with the mutual agreement. These seminars and trainings will be organized according to the mutual interest of both the parties.
- 1.3 Both Party I and Party II will conduct joint research projects and share various chemicals and raw materials for research and study purpose. Both parties will conduct research work and share the optimized data.

1.4 Research students from Party-I can do their research work partially with Party-II for the fulfillment of their degree requirement on the project which is of interest to the Party-II as well. Research data obtained in the investigation will be jointly published.

ARTICLE 2 RESEARCH AND DEVELOPMENT

- 2.1 Both parties are committed to extend their collaboration for jointly working to strengthen their knowledge-based collaboration. For this purpose, Party-I will be leading to provide the expert solution to the problems faced by the Party-II. Research students and lecturers from Party-I and Party II will be involved in order to strengthen the existing products as well as to do the value addition to their products.
- 2.2 Party-I and Party-II will share the laboratories and facilities available in these laboratories.
- 2.3 A comprehensive report for each project on the completion will be prepared from both parties and will be mutually shared by both parties.
- 2.4 Both the parties will meet time to time to maintain the smooth working for ongoing research projects. The Party-I will be obliged to maintain the secrecy of Research and Development (R & D) work as per requirements of Party-II.

ARTICLE 3 AMENDMENTS OR TERMINATION

- 3.1 Any amendments/addition or deletion in the MoA, if requires can be made after mutual consent of both the Parties. However, both the Parties will strictly observe official codal formalities wherever and whenever involved at either end.
- 3.2 This MoA or other mutual detailed agreement(s) shall automatically stand cancelled, if it is deemed necessary at any stage due to the circumstances beyond the control non-fulfillment of the obligation by any Party as laid down in the MoA.

ARTICLE 4 VALIDITY AND TERMINATION

- 4.1. This MoA shall come into force on the date of its signing and remain in force for a period of three (3) years extendable with mutual consent unless either Party notifies the other of its intention to terminate it by giving three months advance notice.
- 4.2. In case of termination of this MoA and other agreements signed under this MoA, the decision on the assets of unaccomplished projects will remain the Party-I and Party-II.

ARTICLE 5 NOTICE
