Moreover, it was informed to the committee members that nine (09) bids were sold, out of which five (05) companies / firms submitted their bids. Accordingly, technical bids were opened at 11:30am in the presence of Central Purchase Committee and firm's representatives on 08<sup>th</sup> November 2017 (copy of attendance sheet is attached).

In this regard, it was briefed to the committee members that the technical bids will be evaluated with refrecne to predefined criteria and also mentioned in bid document. The committee can reject any proposal, irrespective of price, which does not conform to the specified requirements. As per agenda, the committee assessed the bids and after detail evaluation and scrutiny rated the bidders for the supply of equipment for Scientific laboratory, departmetn of Nursing.
