Subject: ENSURE THE FILLING OF INCOME TAX RETURNS FOR TAX YEAR 2023 BY
THE EMPLOYEES OF UNIVERSITY

It has come to our notice that there have been instances of non-compliance with the filing of income tax returns among employees of the university. I would like to emphasize that non-filing of income tax returns can lead to serious legal consequences under Section 182 of the Income Tax Ordinance, 2001.

Under this provision, Penalty proceedings may be initiated against individuals who fail to fulfill their obligation of filing income tax returns. Moreover, non-compliance can also result in the blocking of Mobile Phone SIMs and Utility Connections as per the law.

I urge you to disseminate this information among all employees of the university and ensure their full compliance with the requirement to file their annual income tax returns u/s 114 of Income Tax Ordinance, 2001. This not only fulfills their civic duty but also avoids any unnecessary legal complications.

Furthermore, the FBR intend to establish a facilitation / help desk in the university. This help desk would serve as a central point of contact for employees seeking guidance and assistance with their income tax returns. Trained personnel would be available to answer questions, provide resources, and offer support to ensure that employees can navigate the filing process effectively.

I request your support and cooperation in establishing this help desk at PUMHS University. Your leadership and endorsement of this initiative would be instrumental in its success. I am available to discuss the details further and collaborate on the implementation process.

Looking forward to your prompt response, your cooperation with the revenue administration of the state shall be highly appreciated.


Subject: ENSURE THE FILLING OF INCOME TAX RETURNS FOR TAX YEAR 2023
BY THE EMPLOYEES OF UNIVERSITY

It has been brought to attention through the letter of FBR No. C. NO: ACIR/UNIT-III/SBA/DADU/RTO/HYD/2023-24/1019 Dated: 18-04-2024 that as per section 182 of Income Tax Ordinance 2001, it is compulsory to file an Income Tax Return for individuals whose annual income exceeds Rs. 600,000/-. Some employees of this university who fall into this category have not yet filed their Income Tax Returns.

In this connection, a letter received from FBR regarding this matter (copy is attached). In light of this, it is requested all eligible employees to fulfill their legal obligation by submitting their Income Tax Returns within one month.

Please be aware that failure to comply may result in severe penalties, including suspension of Mobile phone SIMs, Utility Connection and even the cessation of Salary.

To avoid these consequences, it is imperative that file Income Tax Return within specified time frame.
