**NO. PUMHSW/SBA/REG/2021/905-10:** In Pursuance to announcement by the Government of Sindh, regarding closure of all educational institutes, due to prevailing situation of COVID-19, it is hereby notified for the general information of all the concerned that Peoples University of Medical & Health Sciences for Women (PUMHSW), Shaheed Benazirabad will remain completely closed with effect from 26-04-2021 to 23-05-2021, with following conditions.

2. All the academic activities including examinations shall remain suspended with immediate effect till further orders.
3. The heads of the administrative, finance, and admission departments may call essentially required staff with strict COVID-19 pandemic SOPs to assist in official assignments on need basis- which must not exceed 20% of the working strength of respective department / office.
4. No any faculty members / officers and other staff shall leave headquarter without prior intimation and permission.
5. The entry of all visitors / and guest(s) of any employee OR any other outsider person(s) are restricted in PUMHSW Campus.
6. The Teaching Faculty and Staff of Clinical Side shall perform their duties as per routine roster/schedule.
7. Students are directed to vacate the Hostels immediately only foreigner students and Postgraduate trainees are allowed to stay at Hostel with strict compliance of SoPs.

The above instructions must be implemented without any failure in the best interest of public in general and staff in particular.
