
**Terms and Conditions:**

- Auction shall be held strictly in accordance with the Provincial Government Rules and Regulations. All interested parties / bidders shall abide by the conditions described under the relevant provisions of the law.
- Interested bidders / parties shall deposit prescribed token / participation fees / earnest money in form of Pay order / DD in favor of "Vice-Chancellor – PUMHSW, SBA", or in cash without which no one shall be allowed to participate in the auction/ bidding process.
- Successful bidder(s) / party(ies) must deposit 25% of the bid amount immediately after the fall of hammer while remaining balance amount must be paid in cash or through bank draft within 07 calendar days from the day of final acceptance of bid besides payment of applicable advance Income Tax @10% and Sindh Sales Tax @ 10% of total bid amount.

The tax amount shall be borne by the bidder which shall not in any case decrease the amount payable to the University. However, the bidder shall be entitled to get copies / certificates of paid tax challans.

5. The offer of the successful bidder shall be valid for 10 calendar days. After lapse of 10 days, if the successful bidder remains unable to collect the material, then the University reserves right to forfeit 25% deposited amount. No installments or partial payment shall be acceptable in any case.
6. The successful bidder shall have to arrange labour, transport etc. at their own for collecting and lifting of auctioned items. The University shall not be responsible for safe custody of auctioned items or any type of loss or damage in transit.
7. The Auction Committee shall be empowered to add / withdraw any item during auction process. Moreover, within the provisions of law, it also reserves right to cancel / reject any bid at any time without assigning any reason thereof.
